AFFIDAVIT

I, GLANE (GLENN) DUMLAO Y GALAPON,
being legal of age, hereby swear as follows
upon penalty of law:

1) I am a citizen of the Republic of the Philippines
presently residing in the United States of America.

2) I am a former officer of the Philippine
National Police ("PNP") and the former Deputy
Chief for Operations of Task Group Luzon of
the defunct Presidential Anti-Organized
Crime Task Force ("PAOCTF").

3) I arrived in the United States on or
about May 22, 2003 as a non-immigrant B2
visitor through Los Angeles port with authoriza-
tion to remain in this country for a temporary
period not to exceed November 21, 2003. I
remained in the United States beyond
November 21, 2003 because I feared and
I still fear, that if and when I return to
the Philippines, I would again be
subjected to psychological and physical

torture, and/or worse, be killed by people connected to the present Philippine government. These fears and excesses were explicitly contained in my affidavit executed on May 20, 2003, a day before I flee my own country.


4) With this foregoing affidavit, I wish to state that I did not have any active participation in the alleged kidnapping and murder of Salvador Dacer, a well known publicist and his driver, Emmanuel Corbito. My participation to conduct tactical interrogation at that time falls on the purview of regularity in the performance of my duty having been instructed by a superior officer - P/Col AGUIÑO, for a person involved in unseating a duly elected president.

5) That my best recollection on the facts and circumstances of the case is expressly stated in my original handwritten affidavit dated June 12, 2001 as certified by Assistant Prosecutor NILO A PEHALOR on June 14, 2001 at Quezon City, Philippines.

b) I have, of my own free will and volition, executed this affidavit to reiterate and describe the efforts by certain Philippine Government officials to threaten, coerce and intimidate me into falsely implicating their political opponents in order to stymied them in their political career. Further, I reiterate my fear that I will be tortured as what happened to me in the past, and/or be killed by persons connected with the present Philippine Administration if I were to return to the Philippines.

I hereby certify that the foregoing statements made by me are true with no promise of rewards or forceful coercions in making these statements. I am aware that if any of the foregoing statements made by me are knowingly false, I am subject to punishment.
